**BILLS:** The Trustees reviewed the bills

## ROAD COMMISSIONER: No report.

ASSESSOR: Assessor Uwe Rotter reported that they continue to enter data. They have signed up for classes in April.

TRUSTEES: Nothing at this time.

**<u>CEMETERY:</u>** Supervisor Steel read the Cemetery Sexton's report that outlined rate changes. The rate change approval will be placed on the February Agenda.

**SUPERVISOR:** ASSESSOR'S 2022-2023 BUDGET: The budget will be submitted by the end of the month.

GENERAL ASSISTANCE DISCUSSION & MOTION: Supervisor Steel reviewed Township General Assistance-Emergency or Flat. Blackberry's GA is Flat and currently, \$300.00 per month, is allowed, however, the Supervisor may raise the allowance. Supervisor Steel would like to raise the allowance to \$324.00 per month, and the Board agreed.

MOTION TO APPROVE ADJUSTMENT OF DATE OF AUDIT FROM LAST YEAR-RESOLUTION 2021/22-4: Supervisor Steel reported that after working with the new Auditors, this adjustment was necessary. The motion carried.

MOTION TO APPROVE AUDIT ENDING DATE FOR AUDIT GOING FORWARD-RESOLUTION 2021/22-5: Supervisor Steel reported that after working with the new Auditors, this adjustment was necessary. Trustee Veldhuizen made a motion to pass Resolution 2021/22-5, Trustee Childress seconded. Supervisor Steel asked Clerk Hodge for a roll call vote: Veldhuizen-yes, Childress-yes, Steel-yes. The motion carried.

Supervisor Steel led the discussion about closing the Township to the public in response to the recent spike in Covid-19 cases. The Board agreed to close the meeting room to the public until further notice and close the office to the public too. The Board will revisit this decision next month.

**OLD BUSINESS:** None at this time.

**NEW BUSINESS:** Clerk Hodge reminded the Board of the Education Events for 2022.

Trustee Veldhuizen would like the Board to consider having the Township building be a designated emergency location. Supervisor Steel suggested that this could be placed on the Annual Town Meeting Agenda, in April.
